Contractor Safety Management Data

A Contractor Safety benchmarking initiative has been established to collect contractor incident data from utilities. The goal of this initiative is to establish industry benchmarks for contractor safety management; identify leading indicators and determine best in class practices.

Contractor Safety Management Survey

The CMS Survey will collect data through an online form. The data will reflect the total contractor hours and incidents that occur while working for the reporting utility. Required reporting fields include hours, recordable incidents, dart cases, and reportable cases. Reporting areas include Total Company, T&D, and Generation categories. Optional data fields may also be provided such as vehicle miles, vehicle accidents, property damage, flash events, gas leaks, and outages.

Contractor Safety Management Reports

Data will be reported through an online report generator. Online reports may be filtered by date, reporting category, and possibly region. Reports will not include the identity of the utility or contractors. However, a system will be established to contact participants for benchmarking purposes.




EEI-CSP Discussion List View a Summary
